The Four Pillars – Qualifying Questions

Condition: "Can you tell me about the current condition of the property?" Motivation: "What's prompting you to consider selling right now?" Timeline: "If we agree on a price, how soon would you like to close?" Price: "Do you have a number in mind that you'd be comfortable with?"

Wholesaling 101: High-Level Overview

1) Qualify Lead (Condition, Motivation, Timeline, Price) 2) Analyze Deal (ARV, Repairs, MAO) 3) Offer & Contract (Assignable; EMD; Option/Inspection) 4) Open Escrow (Title/Attorney; Send Contract & EMD) 5) Create Buyer Packet (Photos, Comps, Repairs, Access) 6) Market to Buyers (Email/SMS; Showings; Collect Offers) 7) Assign Contract (Buyer EMD; Assignment Agreement) 8) Title Clear & Close (Buyer wires; Seller signs; You get paid) 9) Post-Close (Updates, Receipts, Review, Add to Buyers List)

- 1) Qualify the Lead Check condition, motivation, timeline, and asking price.
- 2) Analyze the Deal Estimate ARV, repairs, and calculate offer range.
- 3) Offer & Contract Present cash offer and secure assignment-friendly contract.
- 4) Open Escrow Send contract & earnest money to title/attorney.
- 5) Market to Buyers Share the opportunity with your investor network.
- 6) Assign the Contract Agree terms with end buyer and collect assignment fee.
- 7) Close Title clears, seller signs, buyer funds, you get paid.
